Rules and Regulations for Edenton Harbor

- 1. All vessels must register with the park office or his/her representative, hereafter referred to as "Management" upon arrival.
- 2. The Management shall not be held liable for any loss, damage or injury suffered by persons and vessels while staying at the Downtown Edenton Harbor Public Piers, hereafter referred to as "the piers"
- 3. No maintenance, painting or repair of vessels is permitted while tied up at the Piers unless approved by management.
- 4. All piers and slips must be kept clear of material i.e.: hoses dinghies, cushions, etc. Water hoses and shore power cords must be neatly positioned so as not to impede traffic to and from adjacent vessels.
- 5. The owner/operator of vessels utilizing the Piers shall be held responsible for his or her guests and any damage caused by said vessel. Boisterous conduct and loud music will not be tolerated.
- 6. If a boat owner cannot be located after a reasonable attempt has been made, the Management reserves the right to have a vessel moved to another location at the owner's expense without the Management being held liable for any damages that result.
- 7. The discharge of bilge fluid or raw sewage is prohibited.
- 8. No fishing, swimming, diving, or crabbing is permitted while at the Piers.
- 9. Commercial advertising, including "For Sale" signs is prohibited without the consent of the Management.
- 10. No vessel may engage in boat charters, the sale of merchandise and services or any other commercial enterprise without prior written agreement from the Management.
- 11. All refuse and trash must be placed in the receptacles provided. Items such as waste oil and batteries cannot be off loaded without the Management's consent.
- 12. Open fires are prohibited.
- 13. Laundry is not to be hung from boat rigging, lifelines, pulpits, or the docks.
- 14. The Management will impound vessels that are abandoned or whose owners have not paid dockage fees.
- 15. Pets must be leashed at all times while traversing the Piers and surrounding waterfront lands and parks.
- 16. Boats that are not marked or identified and licensed by law will not be permitted to use the Pier facilities.
- 17. Boats must be in seaworthy condition and not constitute a fire hazard.
- 18. Consumption of alcoholic beverages is prohibited on the Piers unless in conjunction with an authorized special event, or while on board the vessel.
- 19. The Management reserves the right to have raised and have repaired at the owners expenses any boat, which sinks for any reason while at the Public Piers.
- 20. NO CASH REFUNDS
- 21. No rafting will be allowed, unless authorized by Management or in conjunction with an authorized special event.
- 22. The Management reserves the right to deny access and revoke docking privileges to any person or vessels failing to comply with the above Rules and Regulations.
- 23. If reservations are made for a holiday period (i.e., Memorial Day, Fourth of July, etc.) you are required to give 48 hours notice to the park office if for some reason your plans change. If you do not arrive at the docks by the estimated time of arrival given on your reservation form and no call is received from you stating that you will be late then slip will be offered to person who is on waiting list. Also if you are a no-show you may not be allowed to stay at the docks in the future!
- 24. The captain of the boat will be responsible for docking vessel. Town Personnel are not allowed to touch or handle boats, lines, poles or other devices boater might ask staff to hold/received to aid docking. Staff will meet you at the dock, point out your slip and provide you with the registration information.
